ECU Annual Meeting

The 88th ECU Annual Meeting was conducted in a way designed to allow members to participate by visiting our website or a branch most convenient to them. Members had the opportunity to view the 2022 Year in Review video online, as well as in branch lobbies on Wednesday, March 15, 2023. The 2022 Annual Report was made available to review, and members voted to approve the ECU Board of Directors candidates and the minutes of the 2022 Annual Meeting via ballots that were made available in branches and online between March 6 - March 17, 2023.

As of December 31, 2022, ECU served more than 304,000 members. Total assets were \$7.48 billion and total loans grew to \$6.3 billion. ECU announced a net worth of 12.97%, which is exceptionally strong by regulatory standards.
