



Official Rules for Digital Summer Sweepstakes

NO PURCHASE NECESSARY TO WIN

SWEEPSTAKES PERIOD: The Sweepstakes starts on July 8, 2024, at 12:00 EST and ends on September 15, 2024 at 11:59 AM EST. The Sweepstakes Period will be broken into ten (10) promotional periods running weekly starting at Monday at 12:00 a.m. and ending at Sunday at 11:59 p.m.

ELIGIBILITY: The ECU Digital Summer Sweepstakes is open to any Eastman Credit Union (“ECU”) member who has a primary share account, is a legal resident of the United States, and who is 18 years and older as of date of entry. ECU employees and their immediate families (spouse, parents, children and siblings, and their respective spouses) and individuals living in the same household of an ECU employee are not eligible.

Void where prohibited or restricted by law. All applicable federal, state, and local laws apply.

HOW TO ENTER:

Participants may submit their entry as follows:

Participants are asked to register for ECU Online Banking and Online Statements and log in to Online Banking through desktop or the mobile app during the Sweepstakes Period. Any ECU eligible individual who is registered for Online Banking and Online Statements and logs into Online Banking during a weekly promotional period as described above will be entered into the weekly drawing.

ENTRY REQUIREMENTS: Limit one (1) sweepstakes entry per household. Additional entries received beyond the first Entry will be void. Participants may only win one (1) time. Once a participant is chosen as a winner, their entry will be removed from the sweepstakes.

SELECTION OF WINNERS: The winning entries will be chosen based on a random drawing.

PRIZES: Ten (10) \$2,000 prizes will be awarded, for a total of ten (10) winners. The sponsor reserves the right to select fewer than ten (10) prize winners if, in their sole discretion, they do not receive a sufficient number of eligible and qualified Entries.

Winners will be required to provide a W-9 tax form prior to receiving their prize money. ECU will send each winner a 1099-MISC which will represent the value of winning this Sweepstakes. Any state or federal taxes owed on the prize wings are the sole responsibility of the individual winner.

NOTIFICATION: Winners will be notified by e-mail, mail, or telephone. If prize notification is returned as unclaimed or undeliverable, or if a prize winner cannot be reached within 5 business days from the first notification attempt, then the potential winner may be disqualified and an alternate winner selected. Winner may not transfer prize rights or obtain substitutions or cash redemption.

Winners will be required to sign and return within 7 days a release of liability and consent to use his or her name and likeness for advertising and publicity purposes without further consent or compensation. The prize amount will be paid by check upon receipt of the W-9 tax form. Winners will be required to attend a presentation of the award at their local branch. Failure to comply with these conditions may result in prize forfeiture and selection of a new winner.

ODDS OF WINNING: The odds of winning depend on the number of eligible entries received.

MISCELLANEOUS: By entering, each entrant warrants that ECU and/or its designees may determine the winner without further consideration, notification, or permission of entrants. A complete listing of prize winners may be requested by sending a self-addressed, stamped envelope to the address listed below.

RESTRICTIONS: The following are prohibited and will result in automatic disqualification from the sweepstakes: 1) using any method that artificially increases odds of winning, 2) non-compliance with these Sweepstakes Rules, and 3) any other act which ECU determines that, in our sole discretion, jeopardizes the integrity or proper conduct of the sweepstakes.
